PURPOSE AND INTENDED USE

The purpose of this appraisal is to express an opinion regarding the Fair Market Value of the properties described hereinafter. This appraisal is intended to function solely in the context of said purpose. Any other use will render the entire appraisal null and void and abrogate the appraiser's responsibility.

DEFINITION OF VALUE

The type of value expressed by this appraisal report is Fair Market Value. Fair Market Value is a concept first defined by the U. S. Internal Revenue Service and is the sole concept of value accepted by that body for assessing properties intended for sale, among its other taxation functions. It is here (and normally) understood to represent that amount of money at which a property would change hands between a willing buyer and a willing seller, neither being under any compulsion to buy or sell, and both having reasonable knowledge of the relevant facts.

VALUATION APPROACH

The approach to value employed in this appraisal to estimate Fair Market Value of the subject material is the Market Comparison Approach, also known as the Sales Comparison Method of Valuation. This is one of the three customary approaches in valuation and is the most widely used method for personal property appraisal. It involves the comparison of a subject property with properties of reasonably similar qualities that have sold during a relevant time frame in a relevant market.

EVALUATION

The material being appraised for fair market value consists of the archival papers, historical artifacts, publications and related items belonging to Dr. Franklin E. Kameny, noted gay rights pioneer and activist. Dr. Kameny, a Harvard graduate and World War II veteran, was employed as an astronomer for the Army Map Service, when in 1957 he was fired for being gay based on Executive Order 10450 for "sexual perversion". He attempted to have the case dismissed and eventually wrote his own brief petitioning the Supreme Court to hear his case, but was denied by the court.

He then formed the Mattachine Society of Washington. Quoting from a Mattachine brochure, the society is "the first civil liberties, social action organization dedicated to improving the status of the homosexual citizen through a vigorous program of action".

Dr. Kameny lead the first picket march for gay rights in front of the White House in 1965, and others including the Department of State, Pentagon and, between 1965-1969, an annual July 4th march in front of Independence Hall in Philadelphia. The archive contains over 50 one- and two-sided original picket signs used in these marches. Dr. Kameny demanded a dress code for these marches and maintained a position that being outlandish was detrimental to the responsibility and importance of the movement and what the pickets represented. It is now being accepted that these pickets were equivalent to the women's suffrage and civil rights movements in their attempts for equal rights.

The archive contains a comprehensive history of the gay rights movement in the Washington D.C. area with emphasis on the exclusion of gays in the government because of EO 10450. After Dr. Kameny's dismissal from the government he worked as a "self-characterized paralegal" filing employment, security clearance and discrimination suits against the United States Civil Service, Department of State, FBI and the Pentagon. A detailed account of these suits is documented in the archives and has never been accessed for historical research.

In 1971, Dr. Kameny was the first openly gay person to run for public office as a candidate for the non-voting seat in the House of Representatives and helped unify the gay vote in the District of Columbia. This voting block, now accepted in the District of Columbia, helped Marion Barry win the mayoral election.

In 1973, Dr. Kemany was a leading voice in the American Psychiatric Association delisting homosexuality as a mental illness.

The early years of the gay rights movement was more difficult in the Washington D.C. area because of the government restrictions on gays. It did not have the open support networks San Francisco and New York had. These archives are the historical basis of the gay rights movement in Washington and the legal pressure put on the federal government to change its hiring practices. In *Out For Good, The Struggle to Build a Gay Rights Movement in America*, (Touchstone Books, 1999), authors Dudley Clendinen and Adam Nagourney, frequently site Dr. Kameny's early leadership and impact on the gay rights movement, yet when writing the book, they never had access to these archives. A copy of *Out for Good* and an article from the Washington Post, July

23, 2005, titled "Franklin Kameny Keeps Mementos of His Activism in the Attic, Not the Closet" is enclosed.
